



## 2012 Fox Communities Credit Union High School Scholarship Program

Fox Communities Credit Union will award \$750.00\* scholarships to six high school seniors who are Fox Communities Credit Union members,\*\* who demonstrate community service, and who thoughtfully answer the 2012 essay question.

### Eligible applicants must:

- 1) Be a primary, active member, of FCCU, in good standing.\*\*\*
- 2) Be a graduating high school senior who is continuing their education.
- 3) Demonstrate a commitment to community service.
- 4) Begin secondary education/college within one year of judging notification.

Scholarship applications are available at all Fox Communities Credit Union branches, or online at [www.foxcu.org](http://www.foxcu.org) -click on Member Education tab-then Scholarships. To qualify, applications must be postmarked or dropped off at any of our branches between February 15 and March 15, 2012. Winners will be contacted on April 15, 2012.

### All applicants must submit:

- 1) A completed official Fox Communities scholarship application. May be handwritten. Incomplete applications will be disqualified.
- 2) A 300 word maximum original, typewritten, double-spaced essay. Handwritten essays will be disqualified.

### This year's essay question:

*What does "living within your means" mean to you? How can Fox Communities Credit Union help you and all members achieve this goal?*

### Other rules:

- 1) Winners must agree to allow FCCU to use his/her name and photograph in our promotional materials.
- 2) Decisions of the judging panel are final.
- 3) FCCU is not responsible for lost or misdirected mail.
- 4) All submitted materials become the property of FCCU.

*\* Based on demand, the Credit Union would reserve the right to withhold the award of any of the scholarships.*

*\*\* FCCU employees, directors, committee members, and their immediate families are not eligible.*

*\*\*\* Primary member: name listed first on the account, opened by December 31, 2011*

*Active member: account shows periodic activity*

*Member in good standing: demonstrates sound banking practices*
